- Update will feature new Coordinated Entry events & updates to reports.

Clarity Human Services: November 2022 Feature Updates

Release Schedule:

- All Training Sites: Monday, October 31, 2022
- All Production Sites: Monday, November 14, 2022

CE Events

Communities will now be able to set up and record inferred events as manual events if desired (inferred events are recorded automatically by the system; manual events are recorded by the user in the client enrollment record).

- Manual events will now be configured and recorded within a program-level Events tab instead of through services.
- Inferred events can now be enabled or disabled at the program setup level.
- An “Events” tab will replace the “Provide Services” tab for the CE Project.

Updated Reports

Two reports in Clarity will be getting updated on November 14th 2022. The reports and updates are:

- [HUDX-111-AD] HUD CSV / XML Program Data Export [FY 2022]
- [HUDX-235-AD] CE APR

The [HUDX-235-AD] CE APR will continue to run as expected post-mapping.

Some updates made to [HUDX-111-AD] HUD CSV / XML Program Data Export [FY 2022] may change the output of the report based on the mapping of client services. Client services that were not deleted will no longer appear in the Event.csv and will now appear in the CustomClientServices.csv, CustomClientServiceAttendance.csv, and CustomClientServiceExpense.csv files when “Include Custom Services” is chosen.

Longitudinal Systems Analysis (LSA)

- The Longitudinal Systems Analysis (LSA) report is submitted annually to HUD and provides HUD and CoCs with critical information about how people experiencing homelessness use their system of care.
- This report is a deep dive in all parts of HMIS including program setup, agency setup, and data quality errors not normally found in system reporting.

LSA 2022

- Initial Upload-Starting November 1st, 2022 to the 18th.
- Data cleanup will be from November 1st through January 10th 2023
- Final Submission date is January 11th 2023
- ✓ We have submitted our initial upload and have begun to clean up all data.

- Through these next few months, we will be contacting agencies with questions concerning either clients in their programs (Past & Present) or the programs themselves.
- If you see an email heading with “LSA Data Quality” from either Gary or myself, please know this information is needed in a timely fashion.

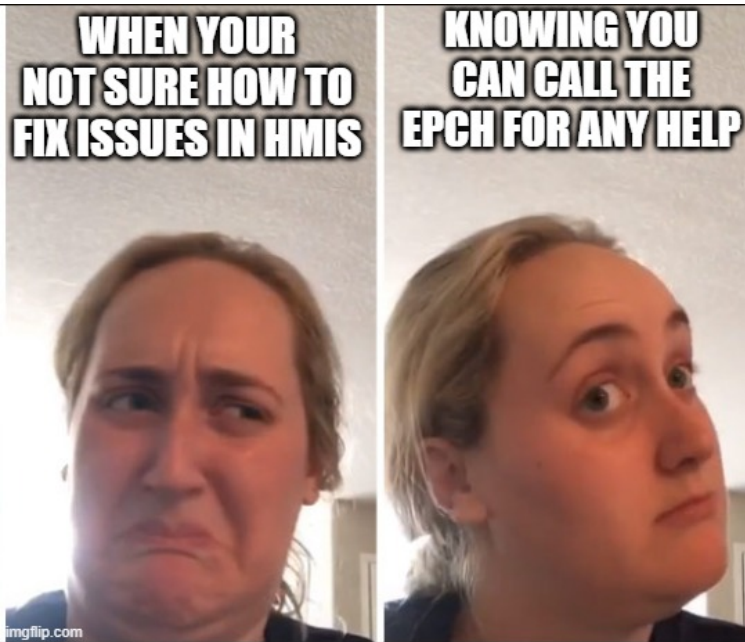
